

Can we reach the psychotic subject in their delusion? Psychopathological theorists often try to find a way to characterise this subject's inner predicament so that their opaque utterances and actions will now rationally hang together. In this pathbreaking work, philosopher and clinical psychologist Richard G. T. Gipps demonstrates how such efforts at rational retrieval actually result in us setting our face against the psychotic subject in their distress.

Bringing together patient memoir, psychopathological observation and philosophical thought, Gipps offers a profound alternative. On the one hand he shows how, by appreciating just why we can't locate rational order within psychotic thought, we can better understand what it is to suffer delusion and psychosis. On the other, he recovers for us the value of such expressive, motivational and symbolic forms of understanding as only become available once we've been turned away at reason's door. In such ways Gipps not only solves the psychopathological problem of delusion, but also shows us how to

bear a truer witness to the psychotic subject in their brokenness, pain and despair.



The AAPP Annual Meeting for 2023 will inquire about the relationships between authority and expertise within the mental health field. Within this theme, a broad range of questions are possible. What counts as expertise? Who decides who is expert and with respect to what domain of knowledge? By what process does expertise become recognized? What kinds of power relations are reflected in various kinds of mental health expertise and authority and how are they embedded in the larger societal context? How can authority and/or expertise be circumscribed or bounded in mental health care? How do these

considerations address accusations of epistemic injustices? How might epistemic injustices be arbitrated? What models of knowledge are implicit in these discussions? An important task in the philosophy of mental health is to characterize the legitimate domain(s) of expertise for each of the groups involved, where they overlap, and how to arbitrate differences in perspective. These tasks are important at the level of general policy decisions such as the development of diagnostic criteria, the selection of foci for research funding, and the allocation of mental health resources, as well as treatment negotiations between the clinician and the individual receiving mental health services.

Ph.D Fellowships Available: Data Science in Psychopathology

Prof.dr. J.W. Romeijn, Faculty of Philosophy, University of Groningen will start a large research project on Data Science in Psychopathology in February, 2023. The project involves three fully paid PhD positions and two postdocs.

Psychiatry and psychology make increasing use of data science methods. This project investigates these methods by using insights from the philosophy of science. The research is innovative in that it combines a mathematical understanding of the methods with knowledge of a scientific context in which these methods are applied, namely psychopathology. The applications of these methods are thereby illuminated, so that they become more reliable and more accountable in both the clinic and the lab. The result is a practice-oriented and formally precise epistemology of data science methods that supports a better use of data science methods in the sciences.

Funding Call: Knowledge Exchange Workshops and Events Award Competition of the *Renewing of Phenomenological Psychopathology* Project funded by the Wellcome Trust

About the Project

Renewing Phenomenological Psychopathology is a new project that aims to apply interdisciplinary approaches to phenomenological psychopathology and diversify the field more broadly. It is an International Exchange Award funded by the Wellcome Trust and will run from April 2022 to April 2024. The leaders of the project are Professors Matthew Broome and Giovanni Stanghellini.

Although phenomenological psychopathology has done much to expand our understanding of mental disorders, the tradition remains somewhat fossilised in the humanities and social sciences of the mid-20th century. We aim to infuse phenomenological psychopathology with cutting-edge developments in this area as well as contributions of analytic philosophy of mind, hermeneutics, structuralist/post-structuralist philosophy, ethics, politics, history, literature, values-based practice, developmental psychology, lived

experience and service user research. The award will commence the reconstruction of phenomenological psychopathology for the 21st century as a democratic discipline with a historicised and inclusive account of the experience of mental ill health.

The Award

We invite applications for workshops and knowledge exchange events that aim to bring together international and interdisciplinary partners to collaborate and to develop new methodologies in phenomenological psychopathology.

There are two workshops per year: one in-person and one virtual. An award of up to £3000 will be offered for an in-person workshop; the award will be used to cover organisational expenses (e.g. the speakers' travel expenses, accommodation and catering). Virtual workshops will not receive direct funds but will receive operational support from the project team for its organisation and delivery, as well as input and direction from the project leaders. Following the completion of the interdisciplinary expansion sandpit, awardees would be required to submit a 750-word summary detailing the outputs of the event.

The deadline for the first round of applications is 9th February 2023 (midnight UK). The deadline for the second round will be in Autumn 2023.

The Application Process

Applicants (individuals or a small group) are required to submit:

- either a 750-word proposal or a 5-minute video that explains which disciplines will be brought together (there should be at least two), what methodological issues (related to phenomenology and other relevant methodological frameworks or tools) will be addressed, why these are important, and how the event will lead to further developments and work relevant to the *Project of Renewing Phenomenological Psychopathology* project and its agenda of inclusivity and diversity. If the event is purely online, please explain how the project team's support will be used. Your proposed sandpit must comply with the BPA/SWIP guidelines for accessible conferences: <u>Guidelines for Accessible Conferences.pages (bpa.ac.uk)</u>.
- A 100-word biography (if you are submitting as a team a short biography would be required for each member).
- A brief 1-page CV for each applicant.

Applications will be reviewed by members of the *Renewing Phenomenological Psychopathology* team and our international advisory board. While we will notify all applicants of the outcome of their submission, we will not supply individual feedback on unsuccessful applications. If your submission is unsuccessful in the first round you are welcome to apply for the second funding round.

Eligibility

You must hold a PhD in a relevant field, or have equivalent research or work experience, or have relevant lived experience.

An important aspect of this project is to diversify the field of Phenomenological Psychopathology. We encourage applications from the widest range of backgrounds, perspectives and experiences to maximise innovation in the field. We are particularly keen to receive submissions from female applicants, LGBTQIA+ applicants, early career researchers, those with lived experience of mental health difficulties, and researchers from the global south/non-WEIRD (western, educated, industrialised, rich, and democratic) countries.

Title: Agency as a framework for thinking of neuropsychiatric disorders

Abstract: The development of new therapeutic methods for intervening in brain function have the potential to influence a person's autonomy and authenticity. In order to determine whether or not this is the case, we need an assay that can measure aspects of agency before and after neurointervention. Here I introduce a framework for thinking about agency as a multidimensional construct, and for conceiving of neuropsychiatric disorders as occupying particular regions in an agency space. We develop an Agency Assessment Tool (AAT) using survey methods. I present preliminary results from the project that suggest that different disorders can be identified with the AAT, which is able to discern control and patient groups, and discuss the prospects for using data-driven tools to come up with ontologies of agency.

Title: Mindfulness and Moral Emotions

Abstract: Many people (particularly Buddhists) believe that being a mindful person is generally a morally good way to be. But this idea appears to conflict with common intuitions about moral emotions—particularly blaming emotions like guilt and resentment—and makes it look like being a mindful person might sometimes make one morally worse. In this paper, I reconcile this tension by (i) presenting a secular (though Buddhism-compatible) account of mindful moral emotion and (ii) arguing that under this account mindful moral emotions do not carry their apparent moral costs, or at the very least such costs are compensated by comparable moral gains. Along the way, I argue that key assumptions motivating the apparent tension are ultimately misguided, while gesturing at ways in which mindful moral emotions (and mindful moral emoters) are plausibly better than their non-mindful counterparts. In the end, I show that you can be a mindful blame-embracer without risking any virtue.

Title: Attention Grabbing Mental Illnesses

Abstract: Mental disorder is defined by DSM-5 in terms of dysfunctional cognition, emotion, and behavior. We will argue that mental illnesses can be understood more fundamentally as failures to control attention. Some mental illnesses involve too much attention (and too little ability to adjust focus), whereas others involve too little attention (or too little ability to maintain focus on what matters). Dysfunctions in attention are then crucial causal elements in the disordered cognitions, emotions, and behaviors in previous definitions of mental illnesses. This new perspective has potential implications for scientific studies and treatments of many mental illnesses.
